The Secretary General's report from January 1 to December 31, 2023

15th July 2024 for single panels and posters proposals.

5. FIEC Congress 2028: call for applications

FIEC renews its call for candidacies for the 2028 Congress. We would be very grateful if you could circulate the attached call among the members of your association.

Any association or institution interested in hosting the FIEC International Congress in 2028 is kindly asked to contact the undersigned, Secretary General of the FIEC.

The organization and financing of the Congress is the responsibility of the local organizers, but the FIEC Board offers logistical collaboration and a modest contribution to the costs of organizing the Congress.

6. Recent FIEC activities

In 2023, the FIEC Board held three online meetings (on Febr. 20, May 29, and Oct. 18) to discuss various matters, particularly the organization of the lecture series celebrating the 75th anniversary of FIEC (see below).

The Board members have the following activities to report on.

CIPSH (Conseil International de la Philosophie et des Sciences Humaines):

Jesús de la Villa (FIEC President and delegate to CIPSH) continued to represent FIEC on the board of CIPSH for the year 2023.

CIPSH held its biennial General Assembly in Tokyo in August 2023, which Jesús de la Villa attended on-line. At the assembly, the results of the different projects developed by CIPSH were presented: Chairs (six, at this moment in different universities around the World); World Logic Day; Global History of Humankind; the Bridges program, promoted by UNESCO, to build bridges in teaching and research between the Humanities and other scientific fields, in particular those of the experimental sciences; CIPSH Academy on the relationship between Chinese and Western cultures (with two conferences in the last two years, one in Lisbon on the contacts of

art and culture through the Pacific in the 17th century, and another one on global ethic, in Stockholm).

The General Assembly approved to create a task force to analyze the situation of the Humanities in education at all levels; Jesús de la Villa, as a member of the CIPSH Executive Committee, was charged with initiating the development of this initiative.

Finally, a new CIPSH Board was elected; Jesús de la Villa was elected Treasurer, continuing a tradition whereby the FIEC representative was also treasurer of the CIPSH.

SIBC (Société Internationale de Bibliographie Classique):

Fausto Montana (FIEC Vice-President and delegate to SIBC) represented the FIEC at the annual meeting of SIBC held in Lille (France) on Oct. 13-14, 2023. The first day was dedicated to the International Conference "L'Antiquité en réserve. Livres, collections, bibliothèques, institutions". On Oct. 14, the annual SIBC General Assembly was held. The President (Pierre Chiron), the members of the board, and the Director of *L'Année Philologique* (Pedro Pablo Fuentes Gonzales) reported on both the financial viability of SIBC and the excellent results achieved in the editorial work for the APh. This positive trend was also confirmed by the representative of the publisher Brepols (Chris Vanden Borre). It was announced that the next SIBC Conference and General Assembly (November 2024) will be held in Granada (Spain).

EASSH (European Alliance for Social Sciences and Humanities):

André Lardinois (FIEC Board member and delegate to EASSH) recalls that EASSH is an advocacy and science policy organisation for the social sciences and humanities with over 65 member organisations, including FIEC. It was closely involved in negotiations about the funding of the Horizon Europe (HE) research program that will last till 2027. In part through the efforts of the EASSH, this program offers more opportunities for SSH disciplines than ever before.

In February 2023 it participated in the midterm evaluation of the HE program. As a result, it was invited to contribute to a small task force that sets guidelines for a new funding scheme (FP10) for research and development to make Europe more durable and resilient. In all these cases it has argued for the necessity of including SSH disciplines in the funding programs if the EU wants to reach the goals it set for these programs.

EASSH welcomed the news about the deal that was struck last summer between the United Kingdom and the European Union about its participation in Horizon Europe. The UK is rejoined on 1 January 2024 as a non-EU member, but UK-based scientists will have access to the funding program on terms which maintain the privileges they enjoyed in the days of EU membership.

On December 7 and 8, 2023, the EASSH General Assembly was held. Plans for the update of Horizon Europe's Strategic plan 2025-2027, which has not been published yet, were discussed and several workshops were held, including one on how to secure data. Throughout the year EASSH organizes webinars on this and other topics that can be followed online and it is worth checking its website for upcoming events (see https://eassh.eu).

7. Lecture series celebrating FIEC's 75th anniversary

2023 marked the 75th anniversary of FIEC (founded in 1948 in Paris). To commemorate this event, the FIEC Board decided to organize a series of on-line lectures on the present and future of our disciplines by highly distinguished and internationally recognized scholars. Among the numerous proposals received from our member associations, 6 speakers were selected for the first series of lectures, which were held in November and December 2023 with the following program:
